

TERMS AND CONDITIONS

1. General

1.1. These terms and conditions apply to the 'Scott gravel bike equipped with Shimano GRX' promotion (the "Promotion"). By participating in the Promotion you are deemed to have accepted these terms and conditions.

1.2. The Promotion is organized by Gravel Union in co-operation with Shimano Europe B.V. ("Shimano"), High Tech Campus 92, 5656 AG Eindhoven, the Netherlands. The Promotion is organized in accordance with the Code of Conduct for Promotional Games of Chance 2014 (Gedragscode Promotieele Kansspelen 2014). Dutch law is applicable on these terms and conditions.

1.3. There is no entry fee required to enter the Promotion.

2. Participation

2.1. The promotion is open to persons aged 18 and over, residing in the European Union and the United Kingdom. Employees of Gravel Union and Shimano and its affiliated companies and the immediate family members (spouse, children) and any person directly or indirectly involved in the development or administration of the Promotion, are not eligible to participate or win.

2.2. Residents of Bosnia Herzegovina, Italy, Greece, Kosovo, Macedonia, Portugal and Sweden are excluded from participation in the Promotion.

2.3. Participants have to register for the promotion via the online subscription form at <https://www.gravelunion.cc>

2.4. The registration period is open from the 3rd of September 2020 until 30th of October 2020. The promotion may be extended for an extra month and if so, will be announced via the Gravel Union website and social media channels. Registrations received outside of this time frame will be excluded from the Promotion. No responsibility can be accepted for entries not received for whatever reason.

3. Promotion Rules

3.1. Participants have to answer the question(s) posted on the website <https://www.gravelunion.cc> , after which a winner will be randomly selected from the Participants who submitted the correct answer.

3.2. The random selection of the winner will take place before the 10th of November, 2020. If the promotion is extended for another month, the winner selection will take place before the 10th of December 2020. The winner will be notified by email in the same week. If the winner does not respond within five working days, the runner up will automatically be designated the winner and will be notified by email.

3.3. If a winner does not confirm acceptance of the prize within 5 working days after being contacted by Gravel Union, the winner is deemed to have rejected the prize and shall no longer be eligible to receive the prize. Shimano shall be entitled to select a new winner.

3.4. Gravel Union reserves the right to withhold one or more prizes if, in accordance with the conditions in paragraph 3, no winner can be appointed before the 15th of December 2020.

4. Prize:

4.1. The winner will receive a Scott gravel bike equipped with Shimano GRX. The exact model and colour will be decided by Scott. There is no guarantee on a specific model nor on colour. The prize will likely be a 2020 model, if not longer in stock a 2021 model will be delivered as the prize. The images shown on the website and promotion pages and social advertising are examples and might differ from the actual prize sent to the winner. Communication about sizes will be handled by Gravel Union. Handover of the prize will be done after consultation with Scott (European head office) and the prize winner.

4.2. All prizes are non-exchangeable, non-transferable and not redeemable for cash or other prizes.

4.3. The prize winner shall be responsible for paying taxes, if any.
